The main objective of this initiative is to bring about sustainable development of villages by implementing various schemes under Unnat Bharat Abhiyan to the rural areas. The aim is to connect higher education institutes with the villages and transmit information through them to create a prosperous rural India.

We are pleased to inform you that our college has been selected by the Ministry of Human Resource Development, Government of India to implement this initiative. We have selected a total of five villages in Satarataluka for this initiative and we have participated in our Pogarwadi village.

Under the Unnat Bharat Abhiyan, we have selected the village Pogarwadi. There are three wards in village. A village baseline survey was conducted on December 18thJuly 2019. With the help of Volunteers from the National Service Department village survey was completed by Mr.D.V.Rupnawar.Baseline survey was conducted through a detailed questionnaire of82familiesvillage, most of the people in the village do farming business. The town Satara is about 10km from this village. The village is well connected to satara-Karandi road. The bus frequency is good to use their own private vehicles. Although the internal road in the village is rough which was done before nine years. The total road length is1.0km.

The village, has a cultural facility, a public playground, a public restroom and three in number. There are also temples of different castes and religions in the village. There is a primary school in the village of Pogarwadi, where there is access to education up to Seventh, and then for the secondary education, one has to travel 1 km outside in the village.

उन्नत भारत अभियानांतर्गत मौजे कुशी या गावात दि. २८ डिसेंबर २०१९ रोजी ग्राम सर्वेक्षण करण्यात आले. या मध्ये राष्ट्रीय सेवा विभागातील स्वयंसेवकांनी सहभाग घेतला. हा सर्वे करण्यासाठी प्रा. एन. व्ही शिंदे व त्याच्या सहकार्यांच्या साह्याने हे ग्राम सर्वक्षण पूर्ण केले. या मध्ये जवळपास २५० कुटुंबांची सविस्तर प्रश्नावलीच्या साह्याने सविस्तर माहिती घेण्यात आली. सर्वेक्षनमध्ये कुटुंबातील सामाजिक, शैक्षनिक व आर्थिक स्थिती पहिली गेली. कुशी हे गाव कृषिप्रधान आहे, गावातील बहुतांशी लोक शेती हा व्यावसाय करतात. या गावातून सातारा हे शहर ९ कि. मी. अंतरावर आहे, जरी मुलभूत सुविधा गावात असल्या तरी या गावात सरकारी बसची सुविधा नसल्याचे दिसून आले आहे. गावापासून राष्ट्रीय महामार्ग हा दीड किलो मीटर अंतरावर असला तरी गावात जाण्यासाठी इतर वाहनाची सोय नाही. लोकांना स्वतःच्या खाजगी वाहनांचा वापर करावा लागतो. गावातील अंतर्गत रस्ता जरी कच्चा असला तरी गावातून महामार्गाला जोडणारा रस्ता हा पक्क्या स्वरूपाचा आहे. एकूण रस्त्याची लांबी २.५ किलो मीटर आहे.

कुशी या गावामध्ये सार्वजनिक सुविधामध्ये सांस्कृतिक हॉल, सार्वजनिक खेळाचे मैदान, सार्वजनिक संडासची सोई असल्याचे दिसून आले आहे व त्यांची संख्या तीन आहे. त्याचप्रमाणे विविध जाती धर्मांची मंदिरे देखील गावात आहेत.

कुशी गावात प्राथमिक शाळा आहे येथे सातवीपर्यंत शिक्षणाची सोय आहे व यानंतर माद्यामिक शिक्षणासाठी गावाबाहेर १ किलो मीटर अंतरावर जावे लागते.



Nune Village Report 2019-20

Ministry of Human Resource Development, Government of India has launched the program, "Unnat Bharat Abhiyan". The main objective of this initiative is to bring about sustainable development of villages by implementing various schemes under Unnat Bharat Abhiyan to the rural areas. The aim is to connect higher education institutes with the villages and transmit information through them to create a prosperous rural India.

We are pleased to inform you that our college has been selected by the Ministry of Human Resource Development, Government of India to implement this initiative. We have selected a total of five villages in Satara taluka for this initiative and we have participated in our Nune village.

Under the Unnat Bharat Abhiyan, we have selected the village nune. There are three wards in village ie Hirapur . A village baseline survey was conducted on December 18th July 2019. With the help of Volunteers from the National Service Department village survey was completed by Dr. (Mrs) R. A. Nalawade. Baseline survey was conducted through a detailed questionnaire of about 100 families of the village, most of the people in the village do farming business. The town Satara is about 7 km from this village. The village is well connected to satara mahableshwar state highway. The bus frequency is good so they can use public vehicles to reduce the pollution. The internal road in the village is rough which was done before nine years. The total road length is 1.0 km. The village has playground ,primary and secondary Marathi medium high school, but the English medium school is 7 km away. The ATM and primary health centre is 3 km away from the village.

We have done meetings with villages officials and stakeholders and also carried out health awareness programs. We have also organized gramsabha with village official and heard problems faced by the people about their needs. We also want to prepare village development plan in consultation with villagers. We have also prepared detail report and want to done documentation of village project work.
